**Concessions Rental Agreement, Release and Assumption of Risk**

**Terms & Conditions:**

1. I have been shown a thorough demonstration on the correct operation and safety features of each piece of equipment and received a copy of instructions.
2. I have been given full and ample opportunity to inspect all rental equipment and find no obvious damage. As a result, misuse or improper operation of equipment, which results in any injury, damage, personal loss or death by you or one of your guests' misuse or negligence, is NOT the responsibility of **Rio Rancho Party Rentals LLC**.
3. I understand that negligence by you or on the part of your guests in regards to operation or use of rental equipment does not constitute negligence on the part of **Rio Rancho Party Rentals, LLC** and will not hold of **Rio Rancho Party Rentals, LLC** responsible for any injury, damage, personal loss or death as a result of you or your guests .
4. You are responsible for the safety, storage, preparation, cleanliness and correct operation of all rental equipment, accessories and food items associated with the rental equipment.
5. All accessories and additional concessions not considered a "connected part" of the rented equipment by **Rio Rancho Party Rentals, LLC** has been received into my possession as new, unopened packages.
6. I have had all questions regarding this addendum and entire rental agreement answered to my satisfaction.
7. I will accept full responsibility for any accident, loss, damage, injury, theft, loss of limb, death or any other conceivable misfortune or accident that may occur as a result of the use, operation, transport or ingestion by me or any of my guests.
8. At the time of accepting delivery of rented items/equipment, the customer agrees to all of the written terms and conditions on this rental contract. The customer also acknowledges that he/she is at least 18 years of age and agrees that they have received all of the rental items on their contract in good order.
9. Customer agrees to assume full responsibility for all of the rented items during the period of time in which the rentals are in their possession including safe and proper use, operation, maintenance and return to **Rio Rancho Party Rentals, LLC**. Customer is fully responsible for all loss, damage or repair.
10. Recovery of Equipment: If customer fails to return all rented items by the agreed time, then the customer agrees to pay for any additional charges that are incurred as a result. If customer refuses to return the rental items back to Rio Rancho Party Rentals, LLC , then the customer agrees that Rio Rancho Party Rentals, LLC, and it's agents will take all reasonable actions needed in order to recover the rented items without legal process or advance notification.

I agree that I have received a Rental Agreement and Release and Assumptions of Risk document. I am of at least 18 years of age as of today's date and fully consent to this agreement as it is written. I understand the risk of liability that is presented in renting the proposed equipment from **Rio Rancho Party Rentals, LLC**. I fully understand all of its contents and that I execute it intelligently, freely and without any duress.
